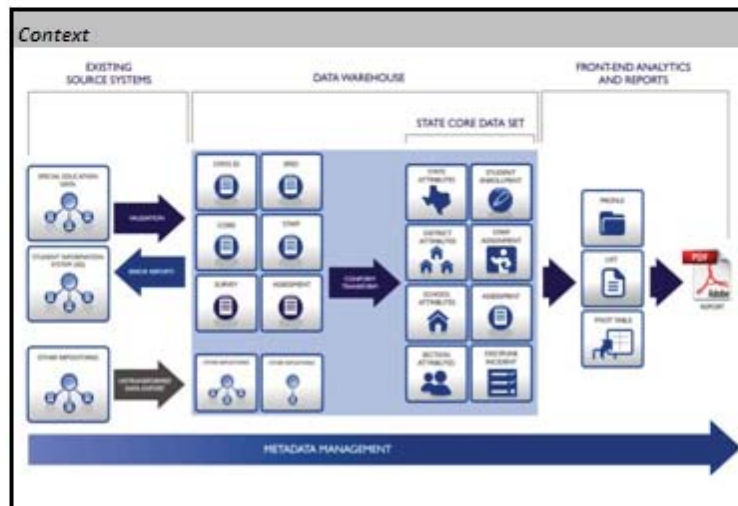
### State Core Data Sets (Version 2.X)

Currently data interviews and self-evaluations of 19 states are represented in the State Core Report. Its goal is to capture the current state of the data elements, definitions and, when possible, code sets of the elements that are present in the State Longitudinal Data System.

The original framing of these elements included their necessity for EDFacts, their necessity to generate teacher-section-student relationships and their necessity for other core ARRA or ACA requirements.

This dataset comprises the core of NEDM's Standards Comparison Report.

This initial dataset represents a primary record level view of the data, as it needs to be outputted from the system.





## National Education Data Model

It displays whether a particular element is a granular (record-level at the source of entry into the system) or derived (composed of granular elements that have been summed, or processed through some algorithm). It also reports on a self-reported assessment of the degree to which an element is essential for (1) identifying the data, (2) executing federal reporting, or (3) for evaluative purposes.

We expect this report to empower and inform the Common Data Standards activity and to act as a resource for anyone buying or building a Longitudinal Data System.

### *Explanation of Spreadsheet*

The spreadsheet that follows describes a common data set of elements all states should be able to produce to support EDFacts, ARRA, and best practices.

Columns A-J are optimized for printing with a single line space for each element. Full definitions can be expanded and viewed.

Columns A-J are optimized for printing with a single line space.

Columns L-CX map elements to EDFacts submission specs.
